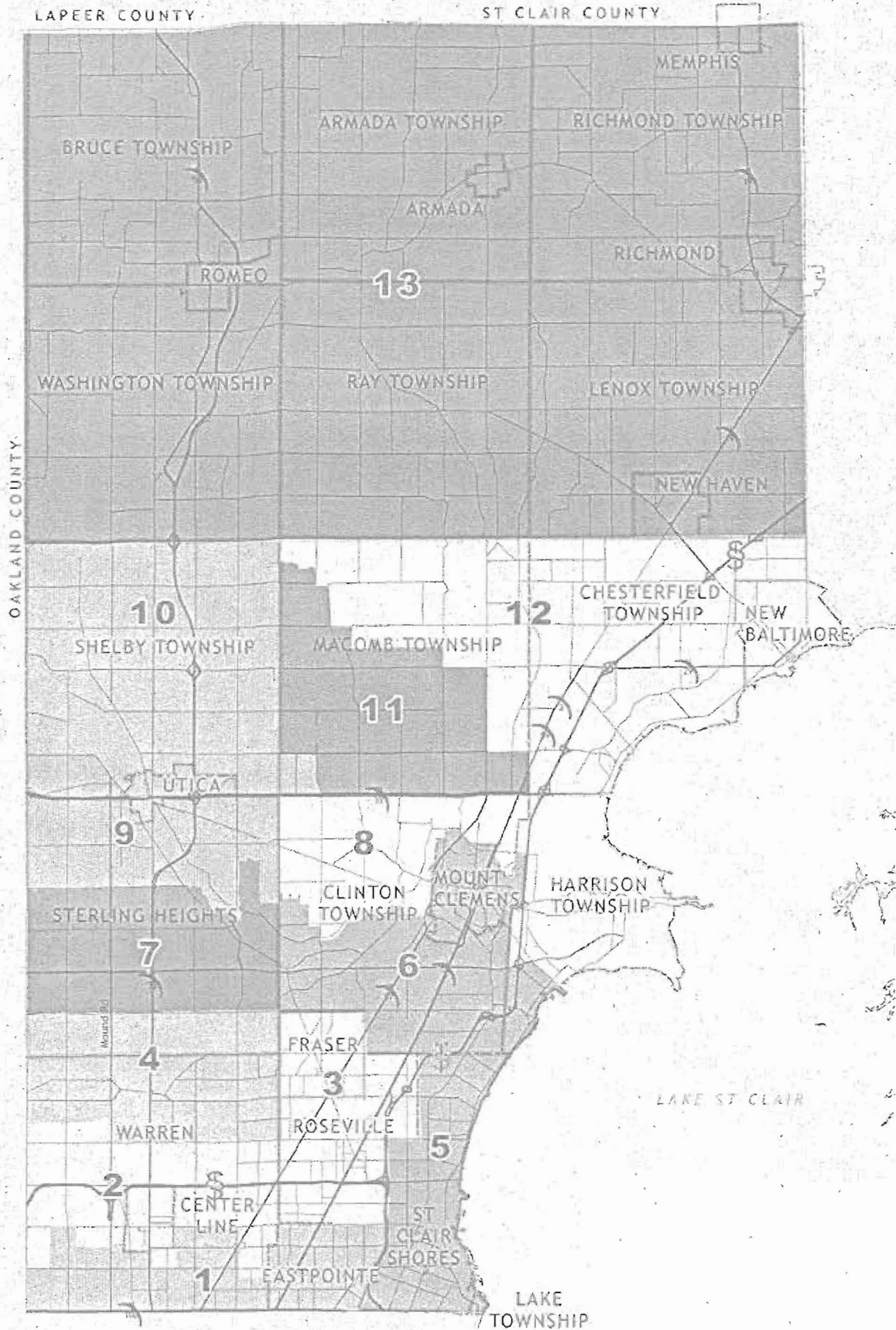

District 1: Start at the corner of M-102/8 Mile Road and Dequindre and head East on 8 Mile Road until you reach Beaconsfield Road, turn North and East to follow the Eastpointe/St. Clair Shores border until you reach the Eastpointe/St. Clair Shores/Roseville border, turn West and follow the Eastpointe/Roseville border until you reach the Warren/Roseville/Eastpointe border, turn South and follow the Warren/Eastpointe border to the Northern border of Warren's Precinct 15, head West along the Northern border of Warren's Precinct 15 to Schoenherr Road, turn and head North on Schoenherr to 10 Mile Road, turn and head West on 10 Mile Road to the Warren/Centerline border, turn South and follow the Warren/Centerline border, when the border turns West continue South on Lorraine until 9 Mile Road, follow 9 Mile West to M-53/Van Dyke Avenue, turn and follow the Western border of Warren Precinct 12, roughly along M-53/Van Dyke Avenue, until you reach the Warren/Centerline border, turn West and follow the Warren/Centerline border West, then follow the border North, then turn West and follow the Northern border of Warren Precinct 18 until you reach Mound Road, turn South until you reach Stephens, head West on Stephens until you reach the Eastern border of Warren Precinct 6, head North along the border, catching Hebest Street, until you reach 10 Mile Road, turn and head West on 10 Mile Road until you reach Ryan Road, head North on Ryan until you reach Frazho Road, go West on Frazho until you reach the Western border of Warren Precinct 6, follow the border South, catching Warner Road south of 10 Mile Road, follow Warner South to 9 Mile Road, turn West on 9 Mile Road until you reach Dequindre, head South on Dequindre until you reach the starting point of M-102/8 Mile Road and Dequindre.

District 2: Begin at the corner of 9 Mile Road and Dequindre, head North on Dequindre until you reach the Red Run Drain, turn and follow the Red Run Drain East until you reach Mound Road, turn and follow Mound Road South until you reach 12 Mile Road, turn and head West on 12 Mile Road until Hayes Road, turn and follow Hayes Road South and continue to follow the Warren/Roseville border, then continue to follow the Warren/Eastpointe border until you reach the Southern border of Warren Precinct 16, head West along the Southern border of Warren Precinct 16 until you reach Schoenherr Road, head North on Schoenherr Road until you reach 10 Mile Road, turn West on 10 Mile Road to the Warren/Centerline border, head South along the Warren/Centerline border, when the border turns West continue South on Lorraine until 9 Mile Road, follow 9 Mile West to M-53/Van Dyke Avenue, turn and follow the Western border of Warren Precinct 12, roughly along M-53/Van Dyke Avenue, until you reach the Warren/Centerline border, turn West and follow the Warren/Centerline border West, then follow the border North, then turn West and follow the Northern border of Warren Precinct 18 until you reach Mound Road, turn South until you reach Stephens, head West on Stephens until you reach the Eastern border of Warren Precinct 6, head North along the border, catching Hebest Street, until you reach 10 Mile Road, turn and head West on 10 Mile Road until you reach Ryan Road, head North on Ryan until you reach Frazho Road, go West on Frazho until you reach the Western border of Warren Precinct 6, follow the border South, catching Warner Road south of 10 Mile Road, follow Warner South to 9 Mile Road, turn West to reach the beginning point of 9 Mile Road and Dequindre.

District 3: Contains ALL of the Cities of Roseville and Frasier.

District 4: Begin at the corner of 15 Mile Road and Dequindre and follow 15 Mile Road East until you reach Hayes Road, turn and follow Hayes Road South to 12 Mile Road, turn and head West on 12 Mile

Road until you reach Mound Road, turn and head North on Mound Road until the Red Run Drain, turn and head West along the Red Run Drain until you reach Dequindre Road, head North on Dequindre Road until you reach the original starting point of 15 Mile road and Dequindre.

District 5: Begin at the corner of M-102/8 Mile Road and Beaconsfield Road, head East following the Macomb/Wayne County border until you hit Lake St. Clair, turn and follow Lake St. Clair north until you reach Crocker, turn and head Northwest on Crocker until you reach Metropolitan Parkway (16 Mile Road) turn and head west on Metropolitan Parkway until you reach Interstate 94, turn and follow Interstate 94 south until you reach Shook Road, turn and head West on Shook until you reach Union Lake Road, turn and head South on Union Lake until you reach the Harrison Township/St. Clair Shores border, turn West and follow the St. Clair Shores/Clinton Township border until the Roseville/St. Clair Shores/Clinton Township border, turn south and follow the Roseville/St. Clair Shores border south until you reach the Roseville/Eastpointe/St. Clair Shores border, continue heading south along the Eastpointe/St. Clair Shores border until you reach the starting point at the corner of M-102/8 Mile Road and Beaconsfield.

District 6: Begin at the corner of 15 Mile Road and Hayes Road, follow 15 Mile Road West to Kelly Road, follow Kelly Road South to 14 Mile Road, follow 14 Mile Road West to Harper Avenue, follow the Clinton Township/St. Clair Shores border to the St. Clair Shores/Harrison/Clinton Township border, turn North along the Harrison/Clinton Township border to the Mt. Clemens/Harrison/Clinton Township border, follow the Mt. Clemens/Harrison Township border North to the Mt. Clemens/Clinton/Harrison Township border, follow the Mt. Clemens/Clinton Township border around to the CN Railroad tracks, follow the CN Railroad tracks South and East to Little Mack Avenue, follow Little Mack Avenue North and West to the southern border of Precinct 33, follow the southern border of Precinct 33 to the Harrington Drain, follow the Harrington Drain north to Harrington Road, turn West to Moravian Drive, follow Moravian North to the northern border of Precinct 10, follow that border West to the Clinton River, follow the Clinton River South and East to Garfield Road, follow Garfield North to 17 Mile Road, head West on 17 Mile Road to Donahue Drive, follow Donahue North to Terra Bella, follow Terra Bella West to Aynesley Drive, follow Aynesley North to Amore Drive, follow Amore Drive West to Skender Drive, head South on Skender to Lorway, head East on Lorway to Eschenburg, head North on Eschenburg to Amore, head West on Amore to Forsythe, head South on Forsythe to Packan, turn West on Packan to Santoni, head North on Santoni to Amore, turn West on Amore to Hayes Road, head South on Hayes Road to the starting point of 15 Mile Road and Hayes Road.

District 7: Begin at the corner of 15 Mile Road and Dequindre and head East on 15 Mile Road until you reach Hayes Road, turn and head North on Hayes until you reach Stadler Road, head West on Stadler until you reach Saal, head North on Saal until you reach the Northern border of Sterling Heights Precinct 32, following the Northern border West until it catches Grove Park Street, following Gove Park West to Aurora Drive, head South on Aurora until Wellington, head West on Wellington until you reach Schoenherr, head South on Schoenherr to the Clinton River, turn and follow the Clinton River North and West until you reach M-53/Christopher Columbus Memorial Freeway and follow M-53/Christopher Columbus Memorial Freeway South and West until 18 Mile Road, turn and head West on 18 Mile Road until Dequindre Road, turn South until you reach the starting point of 15 Mile Road and Dequindre.

District 8: Begin at the Harrison/Chesterfield border at Lake St. Clair, head westward along the border to the Chesterfield/Macomb/Clinton/Harrison township border and follow the Macomb/Clinton Township border to the corner of Hall Road and Hayes Road, turn South on Hayes Road to Amore Dr, turn and head West on Amore to Santoni Drive, head South on Santoni to Packan Drive, head West on Packan to Forsythe, head North on Forsythe to Amore Drive, turn and head West on Amore Drive to Eschenburg Drive, head South on Eschenburg to Lorway Drive, head West on Lorway to Skender Drive, head North on Skender to Amore Drive, head West on Amore Drive to Aynesley Drive, head South to Aynesley to Terra Bella, head West on Terra Bella to Donahue drive, head South on Donahue Drive to 17 Mile Road, head West on 17 Mile Road to Garfield Road, head South on Garfield Road to the Clinton River, head West and North to the border of the 33<sup>rd</sup> precinct, follow the 33<sup>rd</sup> precinct border west to Moravian Drive, head South on Moravian to Harrington Road, head West on Harrington to the Harrington Drain, follow the Harrington Drain South to the border of Precinct 33 and Precinct 26, follow that border West to the Precinct 33 and Precinct 21 border, follow that border South and West to the CN Railroad tracks, follow the CN Railroad tracks North and West to the Clinton Township/Mt. Clemens border, follow the border North, then West to the Clinton Township/Harrison Township/Mt. Clemens border, follow the Mt. Clemens/Harrison Township border Southerly to the Mt. Clemens/Harrison/Clinton Townships border, follow the Harrison/Clinton Township border south to Shook Road, turn West on Shook Road to Interstate 94, turn North on Interstate 94 to Metropolitan Parkway (16 Mile Road), take Metropolitan parkway West to Crocker Boulevard, take Crocker Boulevard South and West to Lake St. Clair, follow the Lake St. Clair shoreline West, then North, then East, then North to arrive back at the starting point of the Chesterfield/Harrison Township border at Lake St. Clair.

District 9: Start at the corner of Dequindre Road and Auburn Road and follow Auburn East to the Utica/Shelby Township border, follow the Utica/Shelby Township border North and East until Schoenherr Road, head North on Schoenherr until 21 Mile Road, turn and head East on 21 Mile Road until Garfield Road, turn South on Garfield Road until M-59/Hall Road and turn and follow M-59/Hall Road West to Hayes Road, head South on Hayes Road until you reach Stadler Road, head West on Stadler until you reach Saal, head North on Saal until you reach the Northern border of Sterling Heights Precinct 32, following the Northern border West until it catches Grove Park Street, following Gove Park West to Aurora Drive, head South on Aurora until Wellington, head West on Wellington until you reach Schoenherr, head South on Schoenherr to the Clinton River, turn and follow the Clinton River North and West until you reach M-53/Christopher Columbus Memorial Freeway and follow M-53/Christopher Columbus Memorial Freeway South and West until 18 Mile Road, turn and head West on 18 Mile Road until Dequindre Road, turn North along Dequindre to reach the starting point of Dequindre and Auburn.

District 10: Begin at the corner of 26 Mile Road and Hayes Road, follow 26 Mile Road to the Macomb/Oakland County border, turn South and follow the border until you reach the corner of Dequindre and Auburn Roads, turn and head East on Auburn until you reach the Shelby Township/Utica Border, follow the border North and East to Schoenherr, turn and follow Schoenherr North to 21 Mile Road, turn and follow 21 Mile Road East to Hayes Road, turn and follow Hayes Road North to the starting point of 26 Mile Road and Hayes Road.

District 11: Begin at the corner of Hayes Road and the Clinton River, follow the Clinton River east to Romeo Plank Road, turn south down Romeo Plank Road to 25 Mile Road, turn East and follow to Romeo Plank Road, follow Romeo Plank Road South to the border of Precinct 16, follow the border East, then follow the border south then follow the border East, follow the same line to cross into the southern border of Precinct 9, turn North up Monoco Drive, turn on Madrone Drive and head East, turn onto Pearlwood Drive and head South, turn on the border of Precinct 9 and follow it across the border of Precinct 24 until you hit North Avenue, turn South and follow North Avenue to 21 Mile Road, turn and head East to the Macomb/Chesterfield Township border and turn South and follow the border to M-59/Hall Road, head West on M-59/Hall Road until Garfield Road, turn and head North on Garfield Road to 21 Mile Road, head West on 21 Mile Road until you reach Hayes Road, turn North on Hayes to reach the beginning point of Hayes Road and the Clinton River.

District 12: Begin at the corner of 26 Mile Road and County Line Road, follow 26 Mile Road westward to Hayes, follow Hayes south to the Clinton River, follow the Clinton River east to Romeo Plank Road, turn south down Romeo Plank Road to 25 Mile Road, turn East and follow to Romeo Plank Road, follow Romeo Plank Road South to the border of Precinct 16, follow the border East, then follow the border south then follow the border East, follow the same line to cross into the southern border of Precinct 9, turn North up Monoco Drive, turn on Madrone Drive and head East, turn onto Pearlwood Drive and head South, turn on the border of Precinct 9 and follow it across the border of Precinct 24 until you hit North Avenue, turn South and follow North Avenue to 21 Mile Road, turn and head East to the Macomb/Chesterfield Township border and turn South and follow the border to the Chesterfield/Harrison Township border, turn East and follow the Chesterfield/Harrison border to Lake St. Clair, turn North and follow the Lake St. Clair shoreline to the boundary of Macomb and St. Clair Counties and follow the Macomb/St. Clair County border north until you reach the starting point of the corner of 26 Mile Road and County Line Road.

District 13: Contains ALL of the Townships of Washington, Bruce, Armada, Richmond, Ray and Lenox, all of the Villages of Romeo, Armada, New Haven, Memphis(Macomb County Portion), and Richmond.

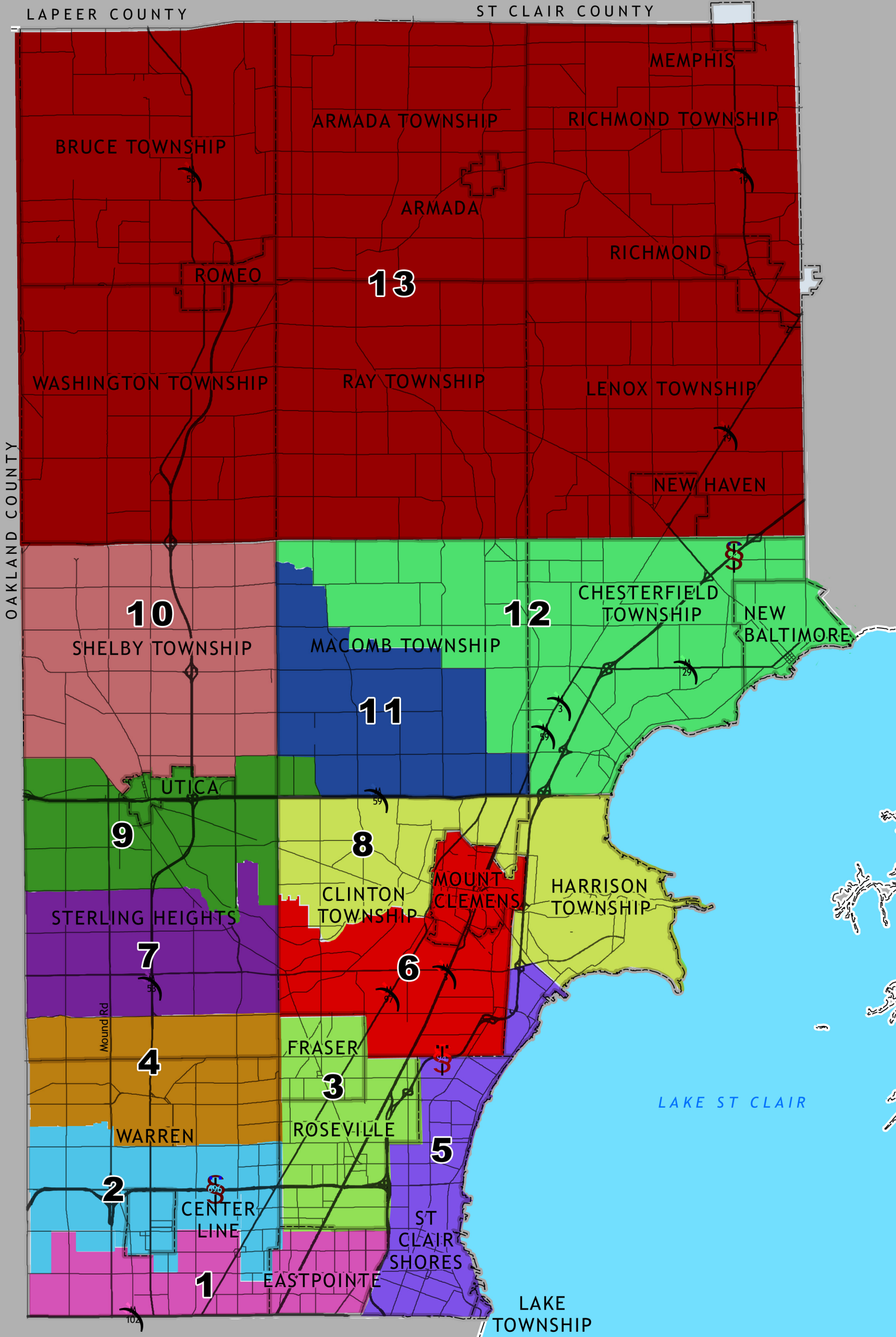
