Background: The Emergency Food and Assistance Program (TEFAP) began in 1981 as a means to reduce the quantity of surplus cheese being stored by the federal government. Since its inception, the number of foods available has varied. All foods are purchased by the United States Department of Agriculture (USDA) under the support program, surplus removal legislation and the commodity entitlement programs and distributed to the state's needy citizens. The Department of Education is designated by the Governor as the state agency responsible for all programs in the state that use USDA donated foods. The Department designated the community action agencies to have the responsibility of distributing commodities at the local level.

Grant Period: October 1, 2007 through September 30, 2008

Funding Amount: \$60,060 (No County match required) Funds are made available based upon a formula on the basis of the number of people unemployed and those below the poverty level. A portion of the total funds available (\$7,200) would be given to pantries to support commodity food distribution. The funds would be based upon the number of households served.

Funding Utilization: An increase in the funding coupled with the demand for food necessitated the need to involve our pantry network to a greater capacity. Pantries would utilize the stipend to pay for costs associated with distributing commodities monthly.

Customer Eligibility Requirements:

- Individuals must be 60 years of age and older and 160% or below the Poverty Income Guidelines; or
- Under 60 years of age and 130% or below the Poverty Income Guidelines.

The Macomb Health Plan (MHP) targets the most vulnerable, needy and underserved. MHP provides programs to enhance the economic and social well being and to improve the level of health of the Macomb County area. MHP may provide such programs only to those seniors who are unable to pay for such services.

The Macomb County Senior Citizen Services' Counseling Program offers professional guidance from three masters'-degreed, licensed professional counselors (one full-time and two part-time). Senior clients are seen in the office, senior centers and most frequently (80%) in their own homes. Counselors work with clients on relational problems, age-related cognitive decline, bereavement, phase of life problems, and adjustment disorders (including depression and anxiety).

The Counseling Program is attached in a supervisory and support role to a state-funded grant program called Grandparents Raising Grandchildren (GRG). Pursuant to grant requirements, counseling staff provide private and group counseling for families involved in the GRG program.

Funding from the Macomb Health Plan will offset the Counseling Program budget of \$146,109. Counseling services will be provided to those seniors who are unable to pay for such counseling services, based on means testing tools developed by Senior Citizen Services. Clients who do not meet the MPH criteria will be billed on a sliding fee scale.

This proposal is presented for consideration by Commissioners Doherty, Duzyj, DiMaria and Tocco. The concept of consolidating laundry operations was first made by Commissioners Doherty and Duzyj at the January 31, 2008 Budget Committee meeting.

The proposal has now been refined as summarized on Exhibit I to do the following:

MARTHA T. BERRY

--Delete 7 full-time laundry positions transferring existing employees to vacant positions where feasible. Martha T. Berry currently has openings for 3 or possibly 4 existing employees. Every effort will be made to find openings in other County departments for the remaining laundry workers.

--Contract with Sheriff to provide jail trustees to perform the laundry operation and provide security for the trustees working at Martha T. Berry.

--Create 1 full-time Leader Position (if necessary) and 4 part-time staff positions to collect the dirty laundry and deliver the clean laundry to patient rooms and the JJC.

JJC

--Delete 2 laundry workers and transfer them to vacant JJC attendant positions.

--Create a contractual line-item to reimburse the Sheriff and Martha T. Berry for performing the laundry function.

SHERIFF

Add 1 full-time Deputy, plus necessary overtime, to oversee the trustees performing the laundry function. Net cost to the Sheriff is zero.

BACKGROUND:

An 1846 Michigan law requires the Register of Deeds to maintain an "entry book" listing property records and noting the day, hour and minute of receipt. With the advent of technology, many Michigan registers of deeds gradually stopped using an entry book and instead started using computer indexes.

Someone wanting to know who owns a piece of property may check the official register of deeds registry. As filing volume dramatically increased in registers of deeds offices across the state, mainly due to mortgage refinancing and home sales, the time it takes to process a document from when it is presented at the counter until it is cleared through the Register of Deeds cashier station, scanned, imaged, microfilmed and mailed back to the filer has also increased.

The time period between the filing of a document and when documents are publicly searchable in the computer index at the register of deeds processing is called the "recording gap." In Macomb County the recording gap has been reduced to only two to three days. In other counties, the gap is much longer. The longer the gap, the higher the risk of real estate fraud. Macomb County Register of Deeds' documents are immediately put into the entry book same day or within 24 hours.

Here is an oversimplified example of the problems the recording gap cause: A seller could sell their house today and the buyer would immediately record the deed. The same seller could sell the same house to a different buyer tomorrow. The second buyer would search the register of deeds records to make sure the seller really owned it. Because of the recording gap, the second buyer may not see the purchase done by the first buyer. The second buyer may pay the seller a "second" purchase price. By the time buyer one and buyer two realize they both purchased the same property, the seller could be long gone.

Newspaper stories about real estate fraud have appeared within the past couple of years. This problem has become so serious that title companies have sued at least one county register of deeds over the lack of an entry book.

The entry book statute was put in place to solve this problem. If there was an entry book, then in the example above, buyer two would search the official register of deeds registry. In Macomb County, if the recording gap was two days, then buyer two would also search item-by-item through the entry book for the last two days. This would put buyer two on notice that buyer one had purchased the same property, even though the transaction had not completed all of the Register of Deeds office processing.

The Macomb County Register of Deeds recently installed the technology to implement an entry book that will post indexes and images on the Internet, greatly reducing the risk of real estate fraud in Macomb County and providing public access. However, the process currently is a two-step process, requiring documents to be scanned twice: once for the entry book and once for the official registry.

Funding is available for this project in the Register of Deeds Automation Fund, which was a fund mandated by Michigan law and may only be spent on improving and implementing technology in Register of Deeds offices.

ARTICLES OF INCORPORATION
COUNTY OF MACOMB ZOOLOGICAL AUTHORITY

These Articles of Incorporation of the County of Macomb Zoological Authority are adopted by the County of Macomb for the purpose of creating a local authority under the provisions of Act 49 of the Public Acts of 2008, MCL 123.1161 *et seq.*

ARTICLE I
NAME

The name of this Authority is the "County of Macomb Zoological Authority".

ARTICLE II
INCORPORATING UNIT

The incorporating unit creating the Authority is the County of Macomb, Michigan.

ARTICLE III
PURPOSE

The Authority is created for the purpose of supporting wildlife conservation and animal welfare and to provide the residents of Macomb County with unique, meaningful and educational experiences involving the appreciation and stewardship of nature.

ARTICLE IV
POWERS AND DUTIES

Section 1. The Authority shall be a public body corporate with power to sue and be sued in its own name in any court of the State of Michigan.

Section 2. The Authority may adopt and amend by-laws for the regulation of its affairs and the conduct of its business.

Section 3. The Authority shall have the power to: (a) contract for zoological services with an accredited zoological institution; (b) levy a tax as provided in Section 13 2008 PA 49, MCL 123.1173; (c) enter into contracts incidental or necessary to carry out the purpose of 2008 PA 49; and/or (d) contract for or retain professional services.

Section 4. The Authority cannot obtain an interest in real property or participate in the governance of an accredited zoological institution.

Section 5. The business that the Authority performs shall be conducted at a public meetings of the Authority held in compliance with the open meetings Act, 1976 PA 267. Public notice of the time, date, ad place of the meeting shall be given in the manner required by the open meetings act 1976 PA 267, MCL 15.261 *et seq.*

Section 6. A writing prepared, owned, or used by the Board in the performance of an official function shall be made in compliance with the Freedom of Information Act, 1976 PA 442, MCL 15.231 *et seq.*

Section 7. The enumeration of specific powers in 2008 PA 49 shall not be construed as a limitation on the general powers of this Authority.

ARTICLE V MEMBERSHIP

Appointment

Section 1. The Authority shall be directed and governed by a Board consisting of five (5) members. The members shall be appointed by the Chairperson of the Macomb County Board of Commissioners with the concurrence of the Macomb County Board of Commissioners.

Eligibility

Section 2. A member must be at least 18 years of age and a resident of the County of Macomb.

Term of Office

Section 3. The terms of the members constituting the first Board shall be for three (3) years. The terms of succeeding members shall be for two (2) years. The initial terms of each member shall commence upon acceptance of the appointment and shall terminate on March 31st 2011. The terms of succeeding members shall commence on April 1st. A member shall serve until his or her successor is appointed.

Compensation

Section 4. Members of the Board shall not receive compensation for services as members of the board, but are entitled to reimbursement for reasonable expenses, including expense for travel previously authorized by the Board, incurred in discharge of his or her duties, as provided in Section 9 of 2008 PA 49, MCL 123.1169.

Vacancy

Section 5. A vacancy occurs on the Board on the happening of any of the events set forth in section 3 of 1846 RS 15, MCL 201.3. Members of the Board may be removed by the Macomb County Board of Commissioners for good cause after a public hearing. Vacancies occurring in the membership of the Board shall be filled in the same way that the original appointment is made and shall be for the period of the unexpired term.

Organization

Section 6. At its first meeting, the Board shall elect a chairperson, a secretary, a treasurer, and any other officers it considers necessary.

ARTICLE VI
PUBLICATION

The County Clerk for the County of Macomb, Michigan shall cause a copy of these Articles of Incorporation to be published once in the Macomb Daily, a newspaper of general circulation within the County of Macomb, and to be filed with the Secretary of State.

ARTICLE VII
AMENDMENTS

Amendments may be made to these Articles of Incorporation as provided in 2008 PA 49.

ARTICLE VIII
TERM

The term of this Authority shall be perpetual.

ARTICLE IX
DISSOLUTION

This Authority may be dissolved by a majority vote of the members appointed and serving. Upon dissolution, the Authority shall only distribute its net assets after payment of debts to an accredited zoological institution.

ARTICLE X
EFFECTIVE DATE

These Articles of Incorporation shall take effect upon filing with the Secretary of State.

WHEREAS, there exists in the County of Macomb a need for
programs to alleviate and prevent conditions of unemployment, to
assist and retain local industrial and commercial enterprises,
and to encourage the location and expansion of such enterprises
in order to strengthen and revitalize the County's economy and
to provide needed services and facilities to the County and its
residents; and

WHEREAS, the Economic Development Corporations Act, Act No.
338 of the Michigan Public Acts of 1974, as amended (the "Act"),
provides a means for the encouragement and assistance of
industrial and commercial enterprises in locating, purchasing,
constructing, reconstructing, modernizing, improving,
maintaining, repairing, furnishing, equipping and expanding in
the County; and

WHEREAS, Americhip International, Inc., a Michigan
corporation (the "Company") has requested the assistance of the
Economic Development Corporation of the County of Macomb (the
"EDC") in connection with the Company's proposal to construct,
equip, and furnish a manufacturing facility in the County of
Macomb to be developed as a commercial enterprise (the

"Project") designed for and capable of providing needed services and facilities to the residents of the County; and

WHEREAS, the Company has advised the EDC that the costs of the Project, including construction, equipment, furniture, architectural, administrative, legal, and financial costs, are estimated not to exceed \$4,000,000 and the acquisition and construction of the Project will create job opportunities for the residents of the County and will aid in the general economic welfare of the County and the State of Michigan; and

WHEREAS, the EDC is authorized by the Act to issue revenue bonds or revenue notes to finance the costs of the Project by making a loan to the Company; and

WHEREAS, the issuance of revenue bonds by the EDC would assist the Company and induce it to establish, modernize, improve, reconstruct and/or expand its business within the County of Macomb; and

WHEREAS, all administrative, legal, financial, or other costs incurred by the EDC are includable in the costs of the Project, and the Company has assured the EDC that the Company will reimburse the EDC for all of said costs, as incurred; and

WHEREAS, the Board deems it desirable, reasonable and necessary to commence the appropriate proceedings in order to assist the Project;

WHEREAS, the EDC proposes to undertake the Project referenced below, to issue debt for such Project and to use a portion of the proceeds of such debt to reimburse expenditures made for the Project prior to the issuance of the debt;

WHEREAS, United States Income Tax Regulations section 1.150-2 provides generally that proceeds of tax-exempt debt are not deemed to be expended when such proceeds are used for reimbursement of expenditures made prior to the date of issuance of such debt unless certain procedures are followed, one of which is a requirement that (with certain exceptions), prior to the payment of any such expenditure, the issuer declares an intention to reimburse such expenditure; and

WHEREAS, the EDC or the Company may make certain expenditures for said Project prior to issuance of the Reimbursement Obligations and may wish to use the proceeds of the Reimbursement Obligations to reimburse all or a portion of said expenditures.

NOW, THEREFORE, it is hereby RESOLVED, as follows:

1. The EDC intends to issue revenue bonds or revenue notes in a maximum principal amount not to exceed \$4,000,000

(the "Obligations") for the purpose of making loans to the Company which will be used to pay the costs of the Project.

2. The EDC hereby declares that it reasonably expects:

(i) that certain costs of the Project will be paid prior to the date of issuance of the Obligations; and

(ii) that a portion of the proceeds of the Obligations will be used for reimbursement of expenditures or the Project that are paid before issuance of the Obligations.

3. Within not more than thirty (30) days following the date of adoption of this Resolution, the Secretary of the EDC is directed to make this Resolution available to the public at the customary location of public records of the EDC. The Secretary is hereby further directed to assure such public availability until the date of issuance of the Obligations.

4. That the proceedings and agreements relating to the EDC's involvement with the Project and issuance of the Obligations shall contain such provisions and details as shall absolutely and unequivocally make certain that under no circumstances will the EDC, the County of Macomb, the State of Michigan, or any of their taxpayers or citizens, ever be required to pay the principal of and interest on, or any costs relating to, the Obligations from tax revenues or other funds of such governmental units, and shall, in addition, contain provisions fully protecting the EDC, the County of Macomb, and the State of Michigan against any other liability and all costs relating to the Obligations of the Project.

5. That by adoption of this resolution, the EDC and the County of Macomb assume no obligation or liability to the Company for any loss or damage that may result to the Company from the adoption of this resolution, from costs and expenses in connection with the construction of the Project, and from costs of the issuance of the Obligations. Any and all costs relating to the acquisition, financing, ownership, or operation of the Project shall be paid from the proceeds of sale of the Obligations or by the Company.

6. That each Obligation, when, as, and if issued in connection with the Project, shall clearly recite in substance that the principal of, interest, and premium, if any, on such bond is payable solely from the revenues received from the Project, and the property, which constitutes the Project, may be pledged or mortgaged as security for the payment thereof.

7. That the firm of Axe and Ecklund, P.C., Grosse Pointe Farms, Michigan, be hereby designated and retained by the EDC as bond counsel with respect to the Obligations to be issued in connection with the Project, and be authorized and directed to

prepare and submit to all appropriate parties all proceedings, agreements, and other documents as shall be necessary or appropriate in connection with the issuance of such Obligations, to make application on behalf of the EDC to the United States Internal Revenue Service and other governmental agencies for such income tax and other rulings and approvals as may be necessary in relation to the issuance of such Obligations, and the Chairperson and Secretary of this EDC are authorized to execute such powers of attorney and other documents as may be appropriate in connection with the foregoing. The legal fees of bond counsel for work done in connection with the Project shall be paid by the Company or ultimately from the proceeds of sale of such Obligations but in no event shall be a cost to the EDC.

The territory surrounding said designated Project Area will not be significantly affected by the Project because the surrounding territory is devoted to commercial/industrial uses and, therefore, this EDC recommends to the Board of Commissioners of the County of Macomb that it designate a Project District Area having the same description as and boundaries coterminous with the Project Area herein designated (See Exhibit A).
3. The EDC commence preparation of a Project Plan, as defined in the Act.
4. The Secretary of the EDC be instructed to communicate the Project Area, as herein designated, to the Board of Commissioners of the County of Macomb, by delivering to each of them a certified copy of this resolution.
5. The Secretary be further instructed to direct a request to the Board of Commissioners of the County of Macomb to certify its approval of the designation of said Project Area and to designate the Project District Area as recommended, without the formation of a Project Citizens District Council as further recommended, all in accordance with the requirements of Section 8(1) and 12(1) of the Act.
6. Pursuant to Section 4(2) of the Act, the Secretary of this EDC be further directed to deliver a copy of this resolution to the Board of Commissioners of the County of Macomb with the request that the Macomb County Board Chairperson promptly appoint two (2) additional directors to this EDC in accordance with the requirements of Section 4(2) of the Act, all upon the conditions that such two (2) additional directors be representative of neighborhood residents and business interests likely to be affected by the Project, located in the Charter Township of Clinton, be authorized to serve and to vote only on issues that directly affect the subject Project, and be authorized to serve only until the earlier of the time the Project is completed in accordance with its Project Plan or the Project is abandoned by the EDC.
7. All resolutions and parts of resolutions insofar as they conflict with the provisions of this resolution be and they are hereby rescinded.

The program has a wide range of service options from which a care plan can be designed that is most responsive to the individual's home care needs; and

Whereas, the MI Choice allocation for FY 2008 is \$124 million, and the Governor recommended a \$27 million increase to MI Choice for FY 2009; and

Whereas, the Senate passed SB 1094, the MDCH FY 2009 budget bill, in March with MI Choice receiving only a \$700,000 increase. MI Choice received a \$1 million increase in FY 2008 – its first funding increase in seven years; and

Whereas, approximately 3,700 people are on the MI Choice waiting list statewide, with 169 people on the list from Macomb County. It would require an additional \$40 million to address the entire waiting list; and

Whereas, the proposed increase is not new money. Money would be shifted from nursing homes based on a projected savings from transitioning Medicaid nursing home residents to the community; and

Whereas, receiving care in the home has shown to be more cost effective for many individuals. The reimbursement rate for MI Choice is \$40 a day, and the reimbursement rate for nursing homes is \$130 a day; and
