## Additional Background Information (If Needed):

The Peer Review Group member appointments shall be done in accordance with Michigan Public Act 345 of 1990 as amended, Michigan Public Act 166 of 2014, MCL 54.269b requiring that Peer Review Group members be appointed by the County Board of Commissioners. Memorandum from the State of Michigan dated July 1, 2014 is attached.

The seven (7) professional surveyors were selected by Martin C. Dunn, P.S. #30081, Macomb County Surveyor Representative. Remonumentation experience letters are attached.

The members will review for approval, the research of public, private claim and property controlling corners in Macomb County. The corner research is provided by surveying companies contracted with Macomb County. The professional expertise of the Peer Review Group assists in the program's goal of restoring, recording and maintaining the monuments used to determine property line boundaries, road alignments, subdivision layouts, as well as, the location of commercial and industrial property.

There is no impact on the Macomb County General Fund. The Remonumentation Program is grant funded and is subsidized 100 percent by the State of Michigan, Office of Land Survey and Remonumentation. The appointments will be funded by the Remonumentation budget; 27023601-80198.

### Additional Background Information (If Needed):

Three (3) Continuously Operating Reference Stations (CORS), located in New Haven, Warren and Washington Township were purchased in 2004 and 2005. The stations were purchased with Macomb County Remonumentation Grant funds. This is an annual grant provided by the State of Michigan, Office of Land Survey and Remonumentation.

CORS OPERATIONS Contract Number 14-5419 transfers the ownership of CORS from the County of Macomb to the Michigan Department of Transportation (MDOT). MDOT has always maintained, serviced and operated the CORS stations. This transfer will allow MDOT to upgrade the stations with the newest hardware and software, resulting in the most current and accurate GPS data available. This data is accessible by and will benefit Macomb County businesses such as agriculture and land surveying.

There is no impact on the Macomb County General Fund.

# Medical Examiner's Office achieves national accreditation

MACOMB COUNTY — An issue that was a major sticking point for the Macomb County Board of Commissioners a year ago recently found resolution when the Macomb County Medical Examiner's Office became nationally accredited.

Dr. Daniel Spitz, the county medical examiner, was notified on July 30 that his office had earned accreditation from the National Association of Medical Examiners (NAME) for the five-year period from 2014-2019. The achievement represents at least five years of work by Spitz and his team. It is also an exceedingly rare accomplishment, as out of more than 2,000 medical examiner offices across the U.S., only 57 — or less than 3 percent — currently have full national accreditation.

"Obviously, this puts us in very elite company," Spitz said. "This is a real testament to the commitment of Macomb County and the commitment of the Medical Examiner's staff, because it took both of those things in order to earn this distinction. Citizens should be very pleased that another county department has achieved the top level of accreditation. This should reassure them that their Medical Examiner's Office is doing work at the highest possible standard."

Last December, when the board renewed Spitz's contract for the next four years, they added one important change: a stipulation requiring Spitz to achieve NAME accreditation for the Medical Examiner's Office and appear before the board every six months to report on his progress.

Spitz's company, Spitz Pathology Group, earned \$377,000 in 2013 for its work in Macomb County. Now that his office has earned national accreditation, Spitz Pathology Group — which consists only of Spitz and a second forensic pathologist, Dr. Mary Pietrangelo — stands to make \$378,000 in 2014 and 2015, \$389,340 in 2016 and \$401,020 in 2017. Spitz is currently the highest-paid employee in Macomb County, earning about \$200,000 per year.

Board Chair Dave Flynn, D-Sterling Heights, believes that the list of terms in Spitz's contract was "a driving motivator" that helped move the accreditation process along more quickly. He pointed out that this goal was achieved faster than he originally thought it would be.

"Reaching national accreditation is a real accomplishment, and Dr. Spitz and his team deserve recognition for making it happen," Flynn said. "But county commissioners also deserve some credit for sticking to their guns and presenting a united front on this issue. A year ago, the naysayers said that this would take years to accomplish and cost hundreds of thousands of dollars. However, it was accomplished in only seven months and without spending a single dollar of taxpayer money."

Al Lorenzo, one of Macomb County's three assistant executives, was quick to stress, though, that Spitz and his team were already doing "an outstanding job" before becoming nationally accredited.

"This elevates the perception of the work being done by the Medical Examiner's Office, if not the actual quality of the work," Lorenzo said. "Still, as with any accreditation, it provides a third-party certification that we are meeting the highest standards. It's another feather in our cap to get this independent seal of approval from NAME."

In order to earn national accreditation, a medical examiner's office first submits a report stating that it has met NAME's rigorous criteria, which number more than 300. Next, a NAME representative visits the office in person and performs a comprehensive inspection of the physical facility, and its operating policies and procedures. Finally,

NAME reviews the site visit report and either grants full accreditation or indicates deficiencies that must first be addressed.

Spitz was proud that Macomb County was able to receive full accreditation on its first attempt, which is a rare feat. He thanked county leaders for giving his office the resources necessary to provide adequate staffing, facilities, equipment and supplies, and he credited his staff for implementing these resources according to NAME's exacting standards.

"The site visit is incredibly thorough and detailed," Spitz explained. "We organized what we had in a way that would make it quickest and easiest for NAME inspectors to go through everything. We made sure that we had real, definable measures to document quality assurance. You can't just say you have all these things in place — you have to prove you have them in place."

According to Lorenzo, the chairman of the NAME Accreditation Committee was so impressed with Macomb County's facility that he later described it as one of the best medical examiner's offices in the country. Lorenzo, who served as president of Macomb Community College for 29 years prior to working in the County Executive Office, is well aware of how difficult the accreditation process can be.

"I was confident in Dr. Spitz and his team," he said, "but I definitely would not have expected that all of those criteria would be met on the first attempt. You can tell that this has been a goal of Dr. Spitz's for several years now. He wanted to make sure that all the i's were dotted and all the t's were crossed before he even invited NAME inspectors out here for a site visit."

This accreditation represents not only a huge professional victory for Spitz, but also a major turnaround from a year in which he faced heavy scrutiny from the Board of Commissioners. In July 2013, the board issued a subpoena for Spitz to present himself at their next meeting after they said that he had been unresponsive to six requests to appear before them since January 2012, a claim that Spitz disputed. Spitz eventually met with the board in September 2013 to address concerns about the budget, operations, workload and accreditation of his office.

Many of the board's questions focused on the possibility that Spitz may be overworked between his caseload in Macomb County and his other duties outside of his main job. In addition to working full-time in the Medical Examiner's Office, where he oversees a staff of 10.5 employees, Spitz also works part-time as the St. Clair County medical examiner, performs independent consulting work and lectures at Wayne State University.


NAME recommends that forensic pathologists perform between 250 and 325 autopsies per year. In 2013, Spitz and Pietrangelo conducted a combined total of 648 forensic exams in Macomb County, including 531 autopsies, which both represent a record high.

Still, now that national accreditation has been reached, Flynn feels like the Medical Examiner's Office has taken an important step. He also added that, over the past year, the Board of Commissioners has developed a much stronger relationship with Spitz and his team, and repaired any previous damage.

"Since that whole debacle last summer, Dr. Spitz has been very forthright and has always kept the board in the loop about his progress," Flynn said. "Macomb County poured a lot of money into creating a first-class medical examiner's facility and on the contract for the people who run it. So we knew that NAME accreditation was a goal that we should be able to achieve."

Spitz also appears ready to put the drama of 2013 behind him.

"Last year was tumultuous at times," he admitted, "but I truly believe that everyone was acting with the best interests of Macomb County in mind. Now we will continue to move forward and try to achieve bigger and better things."

# Michigan cities plan record bond sales to pay for retiree benefits

Michigan municipalities, facing a year-end deadline to borrow for retirement costs, are planning record bond sales to pay for workers' health care and pensions.

Macomb County plans a \$270 million sale of municipal debt, its biggest ever, to finance retiree health-care costs, while Kalamazoo is considering a historic \$100 million bond offer for similar expenses. Bloomfield Hills plans to borrow a record \$17 million for pensions. The law allowing the practice expires Dec. 31.

U.S. states and cities are struggling with how to pay for promises to workers after the recession ravaged their finances. Yet few communities see debt as the answer — sales of revenue-backed pension bonds have tallied \$356 million this year, data compiled by Bloomberg show. Interest rates close to five-decade lows are making it more attractive to pursue the risky strategy of investing borrowed funds in financial markets.

"We can't afford to wait," said Peter Provenzano, Macomb County finance director. "Timing the market is difficult. You could sit on the sidelines and miss out on an opportunity."

### Michigan twist

Municipalities have sold pension bonds since 1985, led by Illinois and California, according to the **Center for Retirement Research** at Boston College. This year's issuers include Orange County and the city of Riverside, both in California.

Investing borrowed cash to pay for health expenses is a new twist in Michigan, where 284 municipalities owed a combined \$12.7 billion in unfunded liabilities for retiree medical care, according to a 2013 **Michigan State University** study. About half didn't require employee contributions.

The practice of issuing debt for retirement costs draws criticism from Matt Fabian, managing director at **Municipal Market Advisors**, as a maneuver that avoids difficult decisions.

"Pension-obligation bonds are almost always a terrible idea," said Fabian, whose research firm is based in Concord, Mass. The borrowing shows a lack of political will to raise taxes or reduce benefits, he said.

The risk for investors is pronounced in Michigan, where Detroit is seeking bankruptcy relief by favoring city pensioners over bondholders, including holders of securities issued to finance pensions, Fabian said.

### Timing risk

From the issuer's standpoint, the sales' timing dictates the success of pension bonds, according to a July analysis by the **Boston College** center. Reinvested proceeds must earn more than it costs to service the debt, which is typically taxable.

Because of stock-market gains following the recession that ended in 2009, the majority of pension bonds have generated positive

returns as of February 2014, according to the center. That's a reversal from mid-2009, when the financial crisis left most of the deals in the red. The analysis is complicated because many of the securities have 30-year maturities, according to the center.

"You really don't know until that end date of the bonds how it turns out," said Jean-Pierre Aubry, assistant director for state and local research at the center.

Grand Rapids won't use debt to finance \$135 million in unfunded health-care liabilities, said Scott Buhrer, the city's chief financial officer.

#### **Bull market**

"The best way to have odds in your favor is to do this when stock prices are depressed," Buhrer said. "We're in the latter stage of a bull market."

Michigan didn't allow such borrowing until a 2012 law, which limits sales to local governments with at least a AA credit rating, third from the top, and requires state approval. A bill to extend the law for a year awaits action in the house after passing the senate. Gov. Rick Snyder supports the extension, said spokeswoman Sara Wurfel.

Borrowing for retirement costs works when coupled with benefit changes, said John Axe, a bond attorney based in Grosse Pointe Farms.

Axe said he represents six municipalities that are considering borrowing for the expenses, though he declined to name them.

Macomb County is paying half the recommended \$30 million annual expense for current and future health-care costs, and won't be able to afford the premiums by the mid-2020s, said Provenzano, the finance director. The bonds will allow the county to keep up with projected cost increases, he said. The plan projects that debt proceeds will earn an average of 7.5 percent annually.

### **Proactive view**

"We're being proactive about this," Provenzano said.

Money from the issue will be invested over the course of a year to adjust to swings in financial markets, he said.

The county has a AA+ grade from Standard & Poor's, its second-highest level. With 850,000 residents, Macomb abuts Detroit's northeast border and is dominated by 155 auto plants and suppliers, and the **General Motors** Technical Center in Warren. The county's \$53,628 median household income compares with about \$48,500 statewide.

Oakland County, which also borders Detroit, sold \$350 million in general-obligation bonds last year to refinance debt issued in 2007 for retiree medical benefits.

Investments from the 2007 issue gained more than projected, resulting in overfunding for health benefits, said Robert Daddow, county deputy executive. The refinancing will save at least \$125 million over the 13-year bond repayment, he said.

The county also reduced costs by closing its defined-benefit health plan to new hires in 2006, Daddow said.

Kalamazoo may sell as much as \$100 million of debt to partly finance \$188 million of retiree health-care liabilities. A city panel this week recommended the bonds and negotiations with retirees and unions to lower medical costs.

The city pays \$6 million annually from its \$50 million general fund toward retiree health care.

If investment returns fall short of repaying the debt and health insurance, the city would renegotiate with employees for savings, said Tom Skrobola, Kalamazoo finance director. Without revenue from borrowing, the city won't keep up with rising medical costs and demands for other city services, he said.

"We've had great success with bargaining, but it's not enough," he said. "It has to be a combined approach."

# Federal judge: Detroit water authority deal not imminent

The federal judge overseeing negotiations involving the Detroit Water and Sewage Department on Monday said a deal to create a regional water authority is not imminent and that discussions don't include payments to the city's general fund

U.S. District Judge Sean Cox responded to a Detroit News report Monday in which two sources close to the negotiations said a deal could be finished within two weeks. The sources detailed terms of the proposed agreement, under which the authority would pay \$50 million a year for 40 years in exchange for acquisition of the water system and its assets.

A third source familiar with the talks on Monday confirmed the details in the report.

"As the court's mediator in this matter, I wish to state that parties to mediation have not reached any definitive agreements, although it is fair to say all parties are demonstrating good faith and responsible leadership," Cox said in a statement.

"Although this issue is still subject to confidential mediation," Cox said, "I will definitively state that these discussions do not contemplate a proposal for the transfer of any funds

d to the city's general fund."

The statement didn't specify where the funds for a transfer might go. The general fund pays for the overall governmental operations of the city.

The News' story did not specify where the proceeds from the transfer would go.

The report comes at a sensitive point in the bankruptcy

<sup>™</sup> negotiations, because Detroit recently proposed a refinance of water department debt. Some fear that bondholders may now be hesitant to move forward.

Cox that even if a deal is reached, it would require an OK from several municipal and legislative bodies and take "substantial time."

In the deal under consideration, sources said, the authority would consist of a six-member board with two appointments coming from the city of Detroit, one each from Wayne, Oakland and Macomb counties, as well as one from the state, according to the source. Currently, the authority that runs the city-owned water system has four members appointed by Detroit and three by the suburbs.

Detroit and suburban officials were ordered into closed-door mediation in April by U.S. Bankruptcy Judge Steven Rhodes over spinning off the water department into an authority. All sides are under a gag order not to talk publicly about negotiations.

Detroit Mayor Mike Duggan on Monday said there have been no conversations about taking money

from the water department and putting it into the city's general fund to pay debt.

"I've said from the beginning that I did not believe money should be taken out of the water system and put into the general fund," Duggan said. "The ratepayers in this city are paying high enough rates. Of course Oakland and Macomb counties have taken exactly the same position. There has been no conversation about a payment to the city in any of these meetings."

Duggan reiterated that on all other issues, he remains bound by the gag order.

Progress on the formation of a regional authority appears to mesh with the city of Detroit bankruptcy proceedings and Duggan's expanded management roles, said Rep. Kurt Heise, R-Plymouth, a proponent of a regionalized water authority.

"There is a greater sense of urgency because the judges would like to see this thing wrapped up along with the bankruptcy," Heise said. "I think they want to get it wrapped up before Duggan would take over all elements of the control over DWSD."

Suburban officials also declined further comment Monday.

"We have and continue to honor the gag order to keep the discussions confidential," said June West, spokeswoman for Wayne County Executive Robert Ficano.

Macomb County Commission chairman David Flynn said in a statement: "I signed a confidentiality agreement so I cannot comment on current discussions. However, from the onset I have supported the concept of a regional authority in order to control the destiny of Macomb County ratepayers' future."
