Call to Order

Sarah Stovall called the Board of Canvassers meeting to order at 1:06 p.m.

Adoption of Agenda

A motion to adopt the agenda was made by Alysa Diebolt and seconded by Lori Mabee; the motion passed unanimously.

Canvass and Certify Results of August 2, 2022 Election

The Board began the canvass of the election and canvassed without incident. The Board recessed at 4:30 p.m. until 9:00 a.m. the next business day.

August 4, 2022 - The Board continued the canvass and canvassed without incident. The Board recessed at 4:30 p.m. until 9:00 a.m. the next business day.

Macomb County Board of Canvassers Unofficial Minutes August 2, 2022 Election Canvass

August 10, 2022 - The Board continued the canvass. Clinton Township, precinct 23AV was brought in for retabulation. Retabulated ballots totaled 491. The container was resealed with seal number 208176. The Board recessed at 4:30 p.m. until 9:00 a.m. the next business day.

August 11, 2022 - The Board continued the canvass. Fraser precinct 2, 2AV, 3AV, and 7AV were brought in for retabulation. A hand count of precinct 2 did not match the number of voters in the poll book, so the election day results stand. The container was resealed with seal number 98700. Precincts 2AV, 3AV, and 7AV were unable to be retabulated because the clerk broke the seal on the ballot container to review the AV return envelopes during the canvass process, so election day results stand. The container was resealed with seal number 98514. The Board recessed at 4:30 p.m. until 9:00 a.m. the next business day.

August 12, 2022 - The Board continued the canvass. Upon completion of the canvass, a motion to certify the results of the August 2, 2022 election was made by Alysa Diebolt and seconded by Lori Mabee; the motion passed unanimously.

After reviewing it, they determined that the issues presented were outside of the purview of the Board of Canvassers and did not prevent them from certifying the election.
