The Macomb County Board of Canvassers met in the Macomb County Election Department Conference Room (32 Market St. in Mt. Clemens), on November 8, 2023.

**Call to Order**

Sarah Stovall called the Board of Canvassers meeting to order at 1:15 p.m.

**Adoption of Agenda**

A motion to adopt the agenda was made by Alysa Diebolt and seconded by Lori Mabee; the motion passed unanimously.

**Public Participation**

None

**Approval of Minutes – October 18, 2023 Meeting**

A motion to accept the minutes was made by Nancy Tiseo and seconded by Alysa Diebolt; the motion passed unanimously.

**Canvass Results of November 7, 2023 Election**

The Board began the canvass of the election and canvassed without incident. The Board recessed at 4:30 p.m. until 9:00 a.m. the next business day.

**November 9, 2023**

The Board continued the canvass at 9:00 a.m. and canvassed without incident. At 3:23 p.m., Alysa Diebolt made a motion to temporarily adjourn until Tuesday, November 14th, seconded by Nancy Tiseo. The motion passed unanimously.

**Call to Order (Reconvene meeting that was temporarily adjourned on November 9, 2023 to complete certification of the November 7, 2023 election)**

Sarah Stovall called the Board of Canvassers meeting back to order on November 14, 2023 at 9:04 a.m.

**Continue to Canvass Results of November 7, 2023 Election**

The Board continued the canvass. Four communities delivered ballots that qualified as MOVE or AV CURE ballots received after the election. Those ballots were opened, duplicated if necessary, and tabulated. After tabulation, they were sealed in a ballot container:

St. Clair Shores, Precinct 16&18 was out of balance due to one jammed ballot being tabulated twice on Election Day. The City Clerk brought the sealed ballot bag to the canvass. Upon opening the bag, the Board discussed that the voted ballots were left in the ballot bin on election night, rather than being sealed in the ballot container. The Board decided not to retabulate St. Clair Shores 16&18 due to chain of custody concerns about the ballots. The ballot container was resealed with seal #208569.

Macomb County Board of Canvassers Unofficial Minutes

The Fraser City Clerk alerted the Board that 45 AV ballots were received prior to election day, but were not received into QVF, nor tabulated in the AVCB. The City Clerk brought those sealed ballots into the canvass. The Board tabulated these AV ballots based on the City Clerk's written explanation.

A motion was made by Lori Mabee and seconded by Alysa Diebolt to certify the results of the November 7, 2023 election; the motion passed unanimously.
