MACOMB COUNTY BOARD OF CANVASSERS FEBRUARY 28, 2024 MEETING UNOFFICIAL MINUTES

The Macomb County Board of Canvassers met in the Macomb County Election Department Conference Room (32 Market St. in Mt. Clemens), on February 28, 2024.

Call to Order

Nancy Tiseo called the Board of Canvassers meeting to order at 9:06 a.m.

Adoption of Agenda

A motion to adopt the agenda was made by Lori Mabee and seconded by Alysa Diebolt; the motion passed unanimously.

Approval of Minutes – February 13, 2024 Ballot Container Certification

A motion to accept the minutes was made by Alysa Diebolt and seconded by Lori Mabee; the motion passed unanimously.

Canvass of February 27, 2024 Election Results

The Board began the canvass of the election and canvassed without incident. The Board recessed at 4:30 p.m. until 9:00 a.m. the next business day.

February 29, 2024 - The Board continued the canvass and canvassed without incident.

March 1, 2024 - The Board continued the canvass and canvassed without incident.

March 4, 2024 – The Board continued to canvass. A motion was made by Nancy Tiseo and seconded by Lori Mabee to add an additional canvass site at 120 North Main Street. The motion passed unanimously.

March 5, 2024 – The Board continued to canvass. Several communities delivered ballots that qualified as MOVE or AV CURED ballots received after the election. After tabulation, they were sealed in a ballot container:
