

**MACOMB COUNTY BOARD OF CANVASSERS
NOVEMBER 5, 2024 ELECTION MEETING
OFFICIAL MINUTES**

The Macomb County Board of Canvassers met in the Macomb County Clerk's Office Conference Room (120 N. Main St. in Mt. Clemens), on November 6, 2024.

Call to Order

Nancy Tiseo called the meeting to order at 9:07 a.m.

Adoption of Agenda

A motion was made by Lori Mabee and seconded by Alysa Diebolt to adopt the agenda. The motion carried unanimously.

Approval of Minutes – October 18, 2024 Container Certification Meeting

A motion was made by Lori Mabee and seconded by Nancy Tiseo to approve the minutes. The motion carried unanimously.

Canvass of November 5, 2024 Election Results

The Board began the canvass of the election and canvassed without incident. The Board temporarily adjourned at 4:30 p.m. until 9:00 a.m. the next business day.

November 7, 2024 - The Board continued the canvass and canvassed without incident. Temporarily adjourned at 6:00 p.m.

November 8, 2024 - The Board continued the canvass and canvassed without incident. Temporarily adjourned at 4:30 p.m.

November 12, 2024 - The Board continued the canvass and canvassed without incident. Temporarily adjourned at 5:00 p.m.

November 13, 2024 - The Board continued the canvass. Roseville AV ballots were brought in and retabulated due to adjudication settings being changed from the original programming. After retabulation, new seal numbers were recorded in the pollbooks.

Alysa Diebolt made a motion, seconded by Lori Mabee, to order the Warren City Clerk to deliver their AV ballots for retabulation. "For the purpose of ballot retabulation, the Macomb County Board of Canvassers hereby order Sonja Buffa, the Warren City Clerk, to deliver the city's absentee ballots, four high speed tabulators, and eight staff qualified and able to run the tabulators to the Macomb County Administration Building, 1 South Main, 1st Floor Lobby, on November 14, 2024, at 8am. All staff and equipment will remain until the Board of Canvassers releases them." The motion passed unanimously.

Temporarily adjourned at 8:30 p.m.

November 14, 2024 - The Board continued the canvass. Warren AV ballots were brought in and retabulated due to adjudication settings being changed from the original programming. Temporarily adjourned at 7:00 p.m.

We reviewed and duplicated timely-received MOVE and AV CURE ballots after the election from Utica, Roseville, Clinton Twp, Center Line, Harrison Twp, Mt. Clemens, Warren, Macomb Twp, Washington Twp, Eastpointe, Richmond City, St. Clair Shores, Shelby Twp, Chesterfield Twp, and Sterling Heights. Temporarily adjourned at 7:00 p.m

November 18, 2024 - The Board continued the canvass. The County Clerk’s office tabulated the MOVE and AV CURE ballots. After tabulation, the ballots were sealed in a ballot container with seal #252453. Temporarily adjourned at 6:30 p.m.

November 19, 2024 - The Board continued the canvass. At 11:38 a.m. they finished canvassing the election. The Board scheduled an election by lot because the Mount Clemens Schools Board of Education race finished with a tie vote. Alysa Diebolt made a motion, seconded by Sarah Stovall to set the date and time for the election by lot to be Wednesday, November 20, 2024 at 3:00 p.m.
