The Macomb County Board of Canvassers met in the Macomb County Election Department Conference Room (32 Market St. in Mt. Clemens), on August 6, 2025.

Call to Order

Nancy Tiseo called the Board of Canvassers meeting to order at 1:08 p.m.

Adoption of Agenda

A motion to adopt the agenda was made by Nancy Tiseo and seconded by Alysa Diebolt; the motion passed unanimously.

Approval of Minutes – May 6, 2025 Election Canvass

A motion to accept the minutes was made by Alysa Diebolt and seconded by Nancy Tiseo; the motion passed unanimously.

Canvass of August 5, 2025 Election Results

The Board began the canvass of the election and canvassed without incident. On August 7th at 11:55am, the chair temporarily adjourned the meeting; the Board will reconvene after the MOVE and AV CURE deadlines to complete the canvass.

August 12, 2025 - Call to Order (Reconvene meeting that was temporarily adjourned on August 7, 2025)

Nancy Tiseo called the meeting back to order at 9:00 a.m. with all canvassers present. Clinton Township, AV12 was off by 6 ballots. The ballot container was brought in. A vote was taken to decide whether to retabulate the entire AV precinct or only the 6 untabulated ballots: Alysa Diebolt voted to retab all ballots. Nancy Tiseo, Sarah Stovall, and Joyce Aragona voted to tabulate the 6 in question. Afterwards it was discovered that the 6 ballots were tabulated on election night and that only a new totals tape was needed. Clinton Township brought in the USB media for that precinct and a new tape was printed, resolving the discrepancy.

AV CURE ballots were brought in and tabulated from Warren and Sterling Heights.

Motion to Accept and Certify the Canvassed Election Results

A motion was made by Nancy Tiseo and seconded by Joyce Aragona to certify the results at 11:07am; the motion passed unanimously.
