REVIEW APPEAL PROCEDURES AND WHAT THE TIME LIMIT IS FOR APPEALS

The procedure for Civil Service applicants appealing their pre-employment physical and / or psychological evaluations has been established as follows:

- The applicant will be notified via email, and a hard copy of the letter will be mailed via USPS, of the failure of the physical and / or psychological evaluation. The applicant will be asked to reply to the email that the letter was received.
- The applicant will be notified that they will have ten calendar days from the date of the letter to notify the Civil Service Commission in writing if they wish to appeal the results of the evaluation.
- As soon as the secretary to the Civil Service Commission receives the appeal, the secretary will coordinate an appointment date and time between the provider and the applicant, where the applicant will be evaluated by a psychologist, or physician, chosen by the Civil Service Commission at the applicant's sole expense.
- The Civil Service Commission reserves the right to choose the physician, or psychologist, for the re-evaluation among a list of providers they maintain. That list is subject to change.
- In the case of a failed physical evaluation, only the failed component needs to be retested, i.e. hearing, drug test, vision.
- Failure of the applicant to appear at the appointed date and time is considered a waiver.
- The outcome of the second evaluation will prevail and is final. No further appeals are permitted.
- The results will be reviewed by the Civil Service Commission for approval or denial to hire.

The procedure for candidates appealing their promotional examinations has been established as follows:

- The candidate will be notified via email, and a hard copy of the letter will be mailed via USPS, of their test scores. The candidate will be asked to reply to the email that the letter was received.
- The candidate will be notified that they will have ten calendar days from the date of the
 letter to notify the Civil Service Commission in writing if they would like to appeal the results
 of the examination. If the candidate would like to appear before the Civil Service
 Commission, the candidate needs to request that in the appeal.
- The secretary to the Civil Service Commission will then add the appeal as an agenda item for the upcoming meeting.
