## <u>Republican and Democratic Party Candidates:</u>

Republican and Democratic Party candidates must file nominating petitions **OR** a \$100 nonrefundable filing fee, no later than **4:00 p.m. on April 23, 2024.** 

Republican and Democratic Party candidates who submit a valid filing for office will be placed on Michigan's August 6, 2024 Primary Election ballot.

## <u>Candidates Without Political Party Affiliation:</u>

Candidates without political party affiliation must file qualifying petitions no later than 4:00 p.m. on July 18, 2024. Candidates without political party affiliation <u>may not</u> file a \$100 filing fee in lieu of qualifying petitions.

Candidates without political party affiliation who submit a valid filing for office will be placed on Michigan's November 5, 2024 General Election ballot.

# AFFIDAVIT OF IDENTITY REQUIRED OF ALL CANDIDATES

All candidates must submit an Affidavit of Identity, in duplicate, when filing for office. Under Public Act 394 of 1984, a candidate who fails to file an Affidavit of Identity as required cannot be placed on the ballot. MCL 168.558 requires any candidate filing an Affidavit of Identity to state on the form that at the date the affidavit was executed all statements, reports, late filing fees, and fines required of the candidate or any candidate committee organized to support the candidate's election under the Michigan Campaign Finance Act have been filed or paid. Therefore, a candidate may not have any outstanding notices of failure to file or late fees with any filing official in the state.

## **CANDIDATE WITHDRAWAL**

Republican/Democratic candidates: April 26, 2024 by 4:00 p.m. Candidates without party affiliation: July 22, 2024 by 4:00 p.m.

#### CAMPAIGN FINANCE

All candidates are required to comply with the Campaign Finance Act filing requirements. Information is available in our office Monday through Friday from 8:00 a.m. to 4:30 p.m.

#### COUNTYWIDE OFFICE QUALIFICATIONS

Must be at least 18 years of age, a citizen of the United States, and a qualified and registered elector of the county by the filing deadline. Candidates for Prosecuting Attorney must be licensed to practice law in the State of Michigan.

#### PETITION SIGNATURE REQUIREMENTS

Petition signature requirements are based on population of the county according to the 2020 census.
