Resolution 23-1

Resolution to establish one precinct in the South Lake Schools District, consolidating The Village of Grosse Pointe Shores, A Michigan City, Precinct 3 and the City of St. Clair Shores, Precinct 3 for the August 8, 2023 election.

This precinct would be designated as “St. Clair Shores, Precinct 3” for the purpose of the South Lake Schools special election on August 8, 2023. The polling location will be the Assumption Greek Church Community Center, 21800 Marter Rd., St. Clair Shores.

The St. Clair Shores City Clerk is an “opt-in” clerk and will conduct the election in this precinct. The Village of Grosse Pointe Shores City Clerk will still conduct certain election duties as required by Michigan election law.
