Re: Appeal of Macomb County Clerk Determination

Dear Ms. Fudge:

The Department of State acknowledges receipt of the appeal regarding the Macomb County Clerk's determination of your sworn complaint challenging Benjamin Schock's petitions submitted for Macomb County Probate Judge. This letter concerns the disposition of your appeal.

Macomb County placed Benjamin Schock on the ballot for Macomb County Probate Judge on April 29, 2024. You challenged Schock's placement on the ballot, arguing that the header was not filled out correctly. The Macomb County Clerk denied your challenge on May 9, 2024. This office received your appeal on May 13, 2024.

The Michigan Election Law, 1954 PA 116, MCL 168.1 *et seq.*, authorizes a person feeling aggrieved by a determination made by the county clerk to have the determination reviewed by filing an appeal with the Secretary of State within 3 days of the clerk's official declaration, unless the third day falls on a weekend or holiday, in which case the appeal must be filed by 4:00 p.m. on the next secular day. MCL 168.552(6).

In Steven A. Freeman v Board of State Canvassers, the Michigan Court of Appeals reviewed a
nominating petition submitted by a candidate for circuit court. There, the heading of the petition
read, "We, the undersigned voters of the County of EATON and State of Michigan, nominate
STEVE FREEMAN as a candidate for the office of CIRCUIT JUDGE, REGULAR TERM
NON INCUMBENT,, TO BE VOTED FOR AT THE Primary Election" The
blank space is where the candidate would enter the district number, if any. Eaton County is the
only county assigned to the 56 th Judicial Circuit.

On review, the Court of Appeals held that not listing "56th District" on a nomination petition for an Eaton County Circuit Court judgeship did not render the petition invalid because there was no corresponding district. *Steven A. Freeman v Board of State Canvassers*, (Docket No. 310933, issued July 13, 2012). As in *Freeman*, because the Macomb County Probate Court is not part of a district, there is no corresponding district to be identified.

Further, with respect to the heading of the petition, there is only one position available for Probate Court Judge – New Judgeship in Macomb County. The heading of the petition is sufficient in that it indicates that the petition was circulated in Macomb County and the position sought is Probate Court Judge, New Judgeship.

Re: Appeal of Macomb County Clerk Determination

Dear Ms. Fudge:

The Department of State acknowledges receipt of the appeal regarding the Macomb County Clerk's determination of your sworn complaint challenging Aaron Hall's petitions submitted for Macomb County Probate Judge. This letter concerns the disposition of your appeal.

Macomb County placed Aaron Hall on the ballot for Macomb County Probate Judge on April 29, 2024. You challenged Hall's placement on the ballot, citing that the header was not filled out correctly. The Macomb County Clerk denied your challenge on May 9, 2024. This office received your appeal on May 13, 2024.

The Michigan Election Law, 1954 PA 116, MCL 168.1 *et seq.*, authorizes a person feeling aggrieved by a determination made by the county clerk to have the determination reviewed by the Secretary of State by filing an appeal within 3 days of the clerk's official declaration, unless the third day falls on a weekend or holiday, in which case the appeal must be filed by 4:00 p.m. on the next secular day. MCL 168.552(6).

In *Steven A. Freeman v Board of State Canvassers*, the Michigan Court of Appeals reviewed a nominating petition submitted by a candidate for circuit court. There, the heading of the petition read, "We, the undersigned ... voters of the County of EATON and State of Michigan, nominate <u>STEVE FREEMAN</u> ... as a candidate for the office of <u>CIRCUIT JUDGE</u>, <u>REGULAR TERM NON INCUMBENT</u>, ______, TO BE VOTED FOR AT THE Primary Election ..." The blank space is where the candidate would enter the district number, if any. Eaton County is the only county assigned to the 56th Judicial Circuit.

On review, the Court of Appeals held that not listing "56th District" on a nomination petition for an Eaton County Circuit Court judgeship did not render the petition invalid because there was no corresponding district. *Steven A. Freeman v Board of State Canvassers*, (Docket No. 310933, issued July 13, 2012). As in *Freeman*, because the Macomb County Probate Court is not part of a district, there is no corresponding district to be identified.
