The undersigned, being all of the members of the Board of County Canvassers of the County of Macomb, State of Michigan, do hereby certify that on Thursday, June 7, 1962, we duly canvassed, examined and considered the statements of votes polled in the Election held on Monday, June 4, 1962, in the territory affected, relative to the following proposition:

" Shall that certain territory located in and being part of Section 34 in the Township of Shelby, Macomb County, Michigan, generally described as bounded on the East by the East line of said Section 34, on the west by the city limits of the City of Utica and the West line of the South 1/2 of the Northeast 1/4 of said Section 34 and on the North by the North line of the Southwest 1/4 of said Section 34 and the North line of the South 1/2 of the Northeast 1/4 of said Section 34, be annexed to the City of Utica, Macomb County, Michigan, in accordance with Act Number 279 of the Public Acts of 1909, as amended"
