## REVIEW AND DISCUSS AMENDING DEPUTY ELIGIBILITY LIST - ELIGIBILITY EXPIRATION DATE

Commissioners discuss amending the Expiration Date column on the Deputy Eligibility List with Corporation Counsel and MCSO liaison Lt Zimny. The Commissioners instruct the Civil Service Secretary to amend the current Deputy Eligibility List to include the following information:

- If the applicant on the Deputy Eligibility List is not a police academy graduate, is not a sworn Corrections Deputy, and is not employed as a law enforcement officer with an outside agency, their expiration date is six months from the date of the MCOLES physical agility test.
- If the applicant is a sworn law enforcement officer with the Macomb County Sheriff's Office, they are "non-expiring".
- If the applicant is employed part time as a sworn law enforcement officer with an outside police agency, they remain "non-expiring" as long as they are employed at least 125 hours per year. They are required to submit documentation from the employer / police agency to the Civil Service Secretary every six months.
- If the applicant is a Certified Law Enforcement Officer or a Police Academy graduate, they remain "non-expiring" for one year from the date of Certification or Academy graduation.

The Civil Service Secretary is directed to create a new Deputy Eligibility List with the above criteria and forward the new Eligibility List to the Sheriff's Office as soon as possible and before the August Civil Service Meeting.

The Civil Service Secretary is to draft a letter to the specific applicants who are currently employed by an outside agency and also a general notice to post on the board at the sheriff's office regarding this new policy. The Civil Service Secretary will forward those drafts to George Brumbaugh, Corporation Counsel for approval.

## REVIEW AND DISCUSS LETTER FROM CONCENTRA REGARDING HAIR DRUG TESTS

- Sheriff's Office liaison Lt. Zimny, Civil Service Commissioners and Corporation Counsel discuss requiring Sergeant-1 applicants to first pass the Written Examination with a minimum score of 70% before proceeding on to the Oral Examinations. Corporation Counsel advised that this is a function of union negotiations and collective bargaining agreements and would have to be addressed at negotiations. The union contract currently allows applicants to proceed to the Oral Examinations regardless of the score on their Written Examination.
- Commissioners discuss reimbursement for lunch costs for Inside Oral Examiners and Outside Oral Examiners. It's decided the Civil Service Commission will reimburse Outside Examiners for lunch, but not Inside Examiners for lunch.
