Commissioners discuss testing and scoring process for Corrections Sgt-1 promotional examinations. It is determined that no rounding is to be applied to test scores. The Civil Service Secretary is instructed to amend the Corrections Sgt-1 Eligibility List to remove the two applicants from the Eligibility List that actually scored below 70%. The two applicants who are being removed from the Eligibility List are to be notified via individual letters and then allow a three day waiting period to post the Amended Eligibility List at the MCSO.
