### AWARDING EDUCATIONAL POINTS FOR COLLEGE CREDITS NOT RESULTING IN A CERTIFICATE OR ASSOCIATES DEGREE

Commissioners and Corporation Counsel discuss the POAM contract provision regarding LE Sgt-1 applicants being placed on a Permanent LE Sgt-1 Eligibility List. Commissioners instruct that there will be two eligibility lists for LE Sgt-1 and that an applicant could be on both lists.

Commissioners and Corporation Counsel discuss the awarding of educational points for college credits not resulting in a certificate or associates degree. Commissioners instruct that going forward all educational credits will be awarded in strict compliance with the language of the respective Collective Bargaining Agreement.
